### 4. CHANGES IN ASSESSMENT METHODOLOGY

The adaptations made in assessment methodology of the Games and Sports subject are specified as follows:

It will be necessary to pass a multiple-choice test that will be carried out virtually through the ILIAS platform or any other authorized by the university for this purpose. The weight of this test on the final grade will be 50%. Completion of the evaluation requires the performance of alternative activities. In this case, in addition to the test type, to pass the subject it is required to prepare and deliver the works requested in the ordinary call. These works will be delivered through the virtual platform. The deadline for delivery of these works will be the day established in the extraordinary call for the evaluation. The weight of these alternative activities on the final grade will be 50%. Teachers may use plagiarism control programs, such as Turnitin, to evaluate these works in order to review and detect incorrect citations or possible plagiarism in them.
