The lectures in large groups related to the theoretical credits have been carried out using virtual modality (videoconferences, explanatory videos, etc.). Regarding the classes in practice groups, it has been carried out through the viewing of videos in which proposals for sessions and activities are exposed, analysis of playful-educational proposals and practical cases. Similar to how it was done prior to confinement, for each practical session previously a working group had to make the presentation of a session. However, in this case, due to the situation of confinement, they have done it through a video or videoconference instead of in person. Finally, in terms of group and individual tutoring, besides maintaining communication by email, and replacing face-to-face tutoring, telematic tutoring has been



carried out (via telephone and videoconference).

#### 4. CHANGES IN ASSESSMENT METHODOLOGY

(Please describe the changes introduced with regard to the original teaching guide)

From the moment of confinement, the "Attendance and/or participation in face-to-face and/or virtual activities" aspect is exclusively evaluated through virtual activities. The weight of 20% is maintained. The evaluation of the "Theoretical concepts of the subject" aspect is carried out by means of the "Delivery of academic essays" instead of by means of an instrument "Theoretical and practical exam". The weight of 50% is maintained.

In the evaluation of the aspect "Carrying out works, cases or exercises", specifically in the exhibition works, they are carried out virtually. The weight of 30% is maintained.

In the case of students who do not follow a continuous assessment, for the ordinary call they must pass the subject as follows; In the case of students who during the ordinary call do not follow a continuous assessment, do not pass some of the assessments or have not submitted to them, for the extraordinary call they must pass the not passed tests as follows:

- For the 20% related to attendance and/or participation, the student must submits a easy that covers the specific competences (portfolio of sessions, theoretical-practical analysis, etc.) in ideal conditions to be overcome, according to indications.
- For 50% of the concepts section of the subject, the student must submits again the work not passed in the ideal conditions to be passed, according to indications.
- For 30% of the work completion section, the student must submit the works requested for completion in ordinary call under the ideal conditions to be passed, as indicated.

There are no changes with regard to the original course syllabus.



#### 6. RESOURCES AND FACILITIES

(Please describe the changes introduced with regard to the original teaching guide)

For the exposition classes in large groups related to the theoretical credits, it has used the resources and infrastructures necessary to hold videoconferences, explanatory videos, etc., such as computer, internet connection, Google Meet for videoconferences, OBS Studio for the recording of videos, YouTube (hidden) to host them, Virtual University (Universidad Virtual) to share the link, etc. Regarding the classes in practice groups, it has been carried out through the viewing of videos in which proposals for sessions and activities, previously carried out by the classmates, analysis of educational-educational proposals and practical cases are exposed. For this, the students' own resources have been used such as a computer, internet connection, YouTube (hidden), smart phones, etc. Finally, in terms of group and individual tutoring, besides maintaining communication by email, and replacing face-to-face tutoring, telematic tutoring has been carried out (via telephone and videoconference). For this reason, telephone and Google Meet have been used.
