Brief Description of Institution

Founded in 1993, the University of Jaén (UJA) is a public institution with campuses in Jaén, Linares, and Úbeda. It is noted for its accessibility and strong international focus, supported by global agreements and the Erasmus+ program. Currently, it hosts 17,000 students, approximately 16.83% of whom are international.

The academic offer includes 50 Bachelor's degrees (specializing in Engineering), 60 Master's, 23 Ph.D. programs, and 9 international double degrees. The faculty consists of 1,113 lecturers, with 82% holding a Ph.D..

In research, UJA excels with 123 active groups and high scientific output. It has produced nearly 26,000 publications, with 60.4% involving international collaboration. Notably, over 56% of these works are in the highest quartile (Q1) of the Journal Citation Report.

-D1.1 Total Institutional Income

refers to the income generated by the institution from research activities and related support activities, including governmental research grants, industry-sponsored research funding, revenues from research contracts, technical service fees, and other research-related income.

-D1.1.4 Of which was derived from donations and endowments

refers to funds received by the institution or institutional endowment from individuals, corporations, foundations, alumni organizations, or other external entities, with no restrictions or only limited restrictions on their use. This excludes revenues from investments of endowment funds.

-D1.1.5 Of which was derived from self-operating activities and investments

refers to the revenues generated by the institution through self-operating activities, service provision, investments (including investments of endowment funds), and the management or utilization of institutional assets.
