Frequently Asked Questions

I. Application process for the Attracting Talent Scholarship

- What does "Academic Transcript of Records" mean'?

Applicants are asked to upload a comprehensive list of their previous studies carried out in a university degree program. The transcript of records contains information about the completed subjects and the corresponding academic marks. It should be presented with the aim of calculating the average performance of students.

- I have my transcript of records in one of the official or co-official languages of my country. Should it be translated into English/Spanish?

Not necessary. It is not required to translate the transcript of records if it is issued in Spanish, English, French, Portuguese or Italian.

- Beside the tuition fee, are there any other costs of the application process which are not covered by the grant?

No, there are no other costs. In case the student is accepted, however, they might need to find ways to make ends meet once they are already in Spain.

- I will finish my degree (BSc) program at the end of the academic year 2019/2020. Can I apply?

Yes. In this case, students are asked to upload a comprehensive list of subjects which you have had so far with the corresponding marks (similar to a transcript of records) indicating the approximate date of completion. Later, students will be asked to upload the remaining. This process should be carried out before the end of **July**, **2020**.

- I have acquired my university degree from a European University. Do I have direct access to a degree program?

Yes. Students are asked to upload their transcript of records emitted by their institution. They do not need to carry out further steps in relation to their studies.

- I have acquired my degree outside Europe. Do I have direct access?

Yes. Students are asked to upload their transcript of records emitted by their institution. They do not need to carry out further steps in relation to their studies.

- I cannot select my nationality on the online application because my country is not listed, what can I do?

Nothing. That means that your country is not elegible because is not listed in 2019/2020's call. Anyway, you can still study at the University of Jaén if you pay your own fees applying at Distrito Único Andaluz.

- I am applying for the scholarship but the app page always displays an error message "captcha incorrect". What can I do?

Just keep on trying till you can save your application.

II. What do I do in case I got selected to participate in one of the 25 scholarship places?

Step 1.

Students need to accept the grant by sending a letter indicating the acceptance of the scholarship.

Step 2.

Select students need to proceed with the prescription process according to the regulations of the UJA and the University District of Andalusia.

Step 3.

Students need to complete the registration process at the University of Jaén.

Step 4.

Before coming to Spain, students are asked to make sure they fulfill the requirements for obtaining a VISA. This includes the acquirement of a private health insurance (sickness/hospitalization), repatriation, accident, travel and civil liability insurance policy covering the whole period of stay in Spain. In case of students from the European Economic Area and Switzerland (28 European Union member states and Iceland, Lichtenstein, Norway and Switzerland), the minimum requirement is to possess the European Health Insurance Card.

Step 5.

Students need to pass 90% of the credits enrolled per year to obtain the financial support for the next year.

III. Awarding the Scholarship

After the deadline, students will be advised whether they are subjects of the grant. If so, they will need to accept the scholarship by sending a letter indicating the acceptance of the scholarship. Grant recipients will receive the support to cover their expenses once the registration process is completed.
